G. STAFF REPORT – Mitch Stogner – Executive Director

Mr. Stogner said that the CTC contacted him and made a request that he be present at their June 29, 2017 meeting in Sacramento. Mr. Stogner said that he attended this meeting and he provided the Board with his comments. A video recording of the June 29, 2017 California Transportation Commission (CTC) meeting was played for the Board.

Chair Hemphill invited Doug Bosco to speak.

Mr. Bosco said he does not think that the CTC has jurisdiction over NCRA. He requested that the CTC lawyers provide their jurisdiction to be demanding business plans. He said that the NCRA relationship lies directly with the State legislature and that there is nothing in the legislature that set up the NCRA that gives the CTC any oversight over this agency.

Chair Hemphill invited Brad Mettam, Deputy of Planning, Caltrans District 1 to offer his comments-

Mr. Mettam said he would like to place the division between Caltrans and the CTC. Caltrans is overseen by the CTC and when he requests documents it is because he knows the CTC can pressure him for certain documents.

H. OPERATOR REPORT – Doug Bosco- NWP Co. Legal Counsel

Mr. Bosco said that NWP Co. is awaiting the Supreme Court decision regarding the “Friend of the Eel River” court case and he said that NWP Co. needs to increase its business and is exploring potential customers from Marin to Sonoma.

I. LEGAL COUNSEL REPORT – CJ Neary

Mr. Neary said that by August 3, 2017 there will be a Supreme court decision regarding existing litigation. He also said that the City of Novato Agreement to maintain Quiet Zones was reached the same day the SMART sales tax was imposed and that they came to a mutual understanding that maintenance will be a very modest responsibility and an MOU may need to be developed in the future.

J. MATTERS FROM THE BOARD

Director Fennell- Dir. Fennell gave an update on the clean-up being done by Timber Heritage Association (THA) at 4 W. 2nd St. in Eureka. THA reported that they have repainted the outside of the building, covered all graffiti, and clean-up has been completed inside the building. Ms. Fennell also said that zero break-ins have been reported near this location in the last two weeks and the local businesses have been working together to create a neighborhood watch group.

Chair Hemphill- Dir. Hemphill reported that Bob Barkley has expressed interest in a possible lease of the building at 4. W. 2nd Street in Eureka and said that he will bring any further information back to the Board as received for review.

Chair Hemphill called a break at 12:21 p.m.
